Dear SHG Parent/Guardian,

Happy New Year! As we begin this new year, it is so important to focus on the positive things that happen every day. In spite of all the violence and tragedy in our world, we know that love is stronger than hate! God is in charge and can bring good even out of seeming bad! I found this verse on a Christmas card I received very meaningful: *The LOVE that begins in our hearts and homes becomes the PEACE that fills the world.*

Thank you for your investment and belief in a Catholic, Dominican education. The Dominican pillars of prayer, study, community and service give our students a strong foundation in character development. It is so important that students have a personal relationship with Jesus Christ so they know they can depend on Him no matter what challenges they face. At Sacred Heart-Griffin, we want Jesus to be the center of all that we are and do. We have a tradition of **100%** of our seniors graduating. Our ACT composite score for 2015-2016 was **24.2**, well above the state average of **20.8**, and exceeds the scores of all area high schools.

The SHG board and administration is very committed to making SHG affordable for all families who want their student(s) to receive a Catholic, Dominican education. After much work on the budget for the school year 2017-2018, the Sacred Heart-Griffin Board of Directors has set the **tuition for the 2017-2018 school year at \$8,550 per student**. Reductions for the second, third and fourth child remain the same and are listed on the Tuition Investment Plan sheet.

Interest earned on the endowment along with monies raised by the Advancement Office through the Annual Fund, Mega-Raffle, Mostaccioli Dinner, the Catholic School Appeal and the annual donation of the Dominican Sisters gives each student a subsidy of \$3,450. The actual cost of educating a student at SHG is \$12,000.

We will make every effort to work with families who demonstrate the need for financial assistance. We want to make SHG affordable for everyone who wants a Catholic, Dominican education. To apply for assistance, please refer to the FACTS Grant and Aid Assessment form which can be found on the SHG website. Click on the *2017-2018 Tuition & Tuition Grant Info* link located in the center of our Home page. To receive financial assistance, the FACTS Grant and Aid Assessment form must be completed. **The completed forms are due by March 15, 2017. Please note that we have less financial aid available this year. It is important that you apply early to assure that you receive assistance.**

Payment plan options are also included with this document. **Please return the Tuition Investment Plan with the registration and course fee of \$300 per student by March 15.** If you have questions or concerns, please contact me at 787-9732 or skoconnor@shg.org. **We want to work with you to assure that your student(s) can attend Sacred Heart-Griffin High School.**

FINANCIAL POLICIES
Sacred Heart-Griffin High School

The 2017-2018 Tuition Investment Plan form along with the 2017-2018 Student Fee (\$300 per child) should be returned to SHG by all families, including those with an incoming freshman, by Wednesday March 15. Return of this form and payment of this fee by March 15 finalizes the student's registration at SHG for the 2017-2018 school year and establishes the family's **eligibility for 2017-2018 tuition grants. In accordance with Illinois High School Association regulations, no grants are awarded on the basis of athletic ability.**

JUNE 15, 2017 FIRST 2017-2018 TUITION PAYMENT

The **first tuition payment** for all families is due **JUNE 15, 2017.** (By **June 30, 2017** for families selecting the FACTS Automatic Payment Plan.)

- a. Families selecting the **ANNUAL PLAN** receive a **\$100 discount** if payment is received by **June 1, 2017. No discount is applied if a grant is awarded. No discount is applied if payment is made with a credit card.** Families who do not meet the **June 15, 2017** payment deadline are subject to a \$25 late-payment penalty.
- b. Families selecting the **SEMESTER PLAN** receive a **\$50 discount on the second installment** if payments are received by **June 1, 2017** and **December 1, 2017. No discount is applied if a grant is awarded. No discount is applied if payment is made with a credit card.** Families who do not meet the **June 15, 2017** and/or **December 15, 2017** payment deadlines are subject to a \$25 late-payment penalty for each missed payment.
- c. Families selecting the **FACTS AUTOMATIC PAYMENT PLAN** pay an enrollment fee of \$45. The **FACTS enrollment** should be completed no later than **May 15, 2017.**
- d. **Failure to meet the June, 2017** payment in **ANY SHG TUITION INVESTMENT PLAN** immediately places the student's **registration, enrollment, and financial grants awarded at SHG in jeopardy.**

PAYMENT POLICIES FOR THE 2017-2018 SCHOOL YEAR

Students whose tuition payments are not current throughout the school year incur the following status:

- a. Not current as of June 15, 2017 and/or December 15, 2017: non-registration status for the 2017-2018 school year and/or the 2017-2018 second semester.
- b. Not current as of May 1, 2018: non-graduation status (seniors); non-registration status for the 2018-2019 school year (juniors, sophomores, freshmen): withholding of report cards and official transcripts (all students).

The **2017-2018 Student Fee** should be paid by **March 15.**

Families with divorced or separated parents, each of whom accepts responsibility for a percentage of tuition and fees payments, may select one of three plans (Annual/Semester/FACTS) for each parent. **If one parent fails to fulfill his or her payment obligations, the other parent must assume financial responsibility for this debt. All charges must be paid by the completion of that current school year.**

PARTICIPATION IN SHG FUNDRAISERS

The one 2017-2018 all-school student fundraiser is the Mostaccioli Dinner/Raffle. Each student is required to sell the assigned quota. Any portion of the student quota not met will be charged to the student's 2017-2018 tuition account.

TUITION/FEE REFUNDS

Tuition is charged on a **quarterly** basis. Unused tuition payments are refunded at the time of a student's withdrawal. **No fees are refunded.**

Student Fee: **\$300** per student to process registration and to cover materials and special expenses of various courses. **Due March 15, 2017.**

Graduation Fee: **\$100** per senior for added graduation expenses. **Due by September 30, 2017.**

Schedule Change Fee: **\$35** due at time of student-initiated schedule change. (No charge for office error or teacher-initiated change.)

Athletic Fee: **\$100** per year per sport (maximum two sports) due at time of student's participation.
